Departments are free to decide which support network / model they would like to adopt in their department subject to the following:

The network should involve individuals who will support the Senior Tutor (PGR) in their role.

Collaborative programmes: Each joint/collaborative programme must have a Joint Management Committee (e.g. EngD Boards, Joint PhD Academic Boards etc.) which meets at least annually to review procedures, student progress, good practice etc.

Precept 13: Assessments/Appeals and Complaints

Assessment procedures and the mechanisms for complaints and appeals should be clearly communicated to research students, supervisors and examiners. Students and supervisors should have a clear and mutually understood mechanism to raise concerns at a departmental level.

Precept 15: Late Stage Review (LSR)

A further review of a student's research ability will be undertaken by 24 months (48 months for part-time students) after the date of initial registration. The form of review will be determined by the student's department and must be clearly communicated to students. Where a student fails to satisfy the assessors at this stage, written feedback should be provided within one month of the review date. Students who have been asked to re-submit* should do so within 3 months of their initial Late Stage Review.

* A student can also be required to withdraw from the College.
